Conditions of Entry



It is a condition of entry of any person to Glenmore Village Shopping Centre that the following Conditions of Entry are adhered to. We ask all visitors to refrain from the following:

1. Disorderly or disruptive conduct of any nature in such a way as to cause inconvenience to others, use of obscene or insulting language/gestures, ethnic/racial slurs, sexually explicit language/conduct, running, yelling, fighting or be in possession of an object/weapon intended to cause bodily harm.
2. Violence, threats of violence, fighting, physical abuse or physically or verbally threatening any person, or hostility of any kind.
3. Displaying or wearing any item which depicts sexually explicit activity, illegal activity or obscene or offensive language, wearing clothing or lack of clothing that is likely to create a disturbance or embroil others in open conflict or offends community standards of decency, or that impinges on the sensitivities of others in the centre.
4. Failing to wear footwear and a shirt.
5. Skateboards, scooters, roller blades or similar shall not be used or ridden in or about Glenmore Village Shopping Centre.
6. Any form of solicitation, sales of products or services, or distributing hand bills, leaflets, commercial advertising or promotional material of any kind or offering samples of items, which are sold, available for sale or available in exchange for a donation or contribution without prior written permission of Centre Management.
7. Glenmore Village Centre is a SMOKE FREE area. Smoking and the use of e-cigarettes is prohibited in the Centre and Centre car parks.
8. The use of photographic, video or audio recording equipment by any person in or around the centre, for reasons other than personal, without permission from Centre Management is prohibited.
9. Creating litter by discarding paper, glass or other material of any kind, anywhere except for a trash receptacle.
10. Defacing, damaging, destroying or removing any real or personal property constituting part of or located on the mall property.
11. Bring small animals on to the centre property with the exception of small animals in the company of persons trained to assist physically challenged patrons, those animals going to or from residential towers (must be carried at all times) or involved in centre sponsored events.
12. Carrying or displaying weapons of any kind except those carried by certified law enforcement officers in the performance of their duties.
13. Being intoxicated and/or possessing or being under the influence of illegal drugs.
14. Possessing any open container of alcohol or consuming alcohol anywhere except in businesses licensed as BYO or licensed to sell alcoholic beverages.
15. Selling or providing alcohol or tobacco products to underage persons; purchasing alcohol or tobacco products by underage persons.
16. Engaging in any act, activity, or behaviour which by its nature is illegal and/or in violation of any statute, law, rule or ordinance.

This list is not all inclusive and may be modified at any time by the management of this centre.

Violation of this code of conduct may result in expulsion from this property in addition to any other legal remedies that centre management may choose to exercise. This shopping centre is private property and no rights shall accrue to the public by virtue of the public's entry into this centre or on centre property. This Code of Conduct is not intended to deprive any person of their applicable civil rights or liberties under the law. If you feel your rights are being violated, please notify the centre management office.
